Phipps' Under the Sea Creature Challenge

- 1. Promotion Period: Phipps' Create Your Own Under the Sea Creature Challenge (the "Promotion") begins Fri., June 14 and will be open until Sun., Sept. 8. Up to 10 pieces of artwork will be chosen per month and their work will be up in said month.
- 2. Eligibility: Open to legal residents of the fifty (50) United States and Washington D.C. who are 12 years of age and younger as of date of entry. Employees of Phipps Conservatory and Botanical Gardens and their respective parent, affiliated companies, agents and immediate family (defined as parents, spouse, children, siblings, grandparents) of each of such employees, and all are domiciled are NOT eligible. Participation constitutes entrant's full and unconditional agreement to these Official Rules, which are final and binding in all matters related to the promotion.
- **3. Sponsor/Administrator:** Phipps Conservatory and Botanical Gardens at One Schenley Park Pittsburgh, PA 15213.
- **4. Requirements:** Any and all mediums are welcome to be used to create artwork. Due to size restrictions of framing, artwork should be no bigger than 8.5" x 11" and presented in portrait format. Artwork must also contain at least one creature. The artist's creation **must be an original design**.
- **5. How to Enter:** During the Promotion Period, visit phipps.conservatory.org/create-your-own-under-the-sea-creature and access the Promotion Application and submit artwork of sea creatures to Phipps Conservatory and Botanical Gardens.
 - **a.** Limit one (1) entry per person per month.
 - **b.** No purchase necessary. All participants must comply with these Official Rules and any registration instructions in order to be eligible.
 - **c.** Physical entries of artwork will not be accepted.
- **6. Notification:** Artists whose creations are selected for display in Phipps' Summer Flower Show will be notified by email.
- 7. Random Drawing: Up to 10 sea creatures will be chosen at random each month and displayed during Phipps' Summer Flower Show. Sea creatures will be displayed for approximately one month and then displays will be turned over to showcase additional selections.
- 8. Release and Limitations of Liability: By entering this contest, parents and caregivers authorize Phipps Conservatory and Botanical Gardens (Phipps) to publish the submitted artwork and descriptive text along with the first name and age of the child artist for use by Phipps in any and all of its publications and in any and all other media, whether now known or hereafter existing, controlled by Phipps, in perpetuity, and for other use by Phipps. Submitters attest that they are the parent or legal guardian of the children listed below and that I have the authority to authorize Phipps to use their work. They acknowledge that since participation in publications and in any and all other media produced by Phipps is voluntary, no financial compensation will be received. They release Phipps, its contractors and its employees from liability for any claims by any party in connection with their participation or the participation of the children.
